## NEWS NOTE

THE EVERGREEN NEWS, circulation 5,000, was established in 1970-71 to be VECA 's newsletter. This monthly neighborhood newspaper comes to you free. It is published by an all volunteer staff, delivered by volunteers, and is paid for by ads purchased by neighborhood businesses, churches, and schools. Regular staff meetings are held the 1st and 3rd Thursday of each month. Deadline for copy and ads is the 1st Thursday for the following month's issue

## NAME CHANGE FOR VECA

Since receiving a State Charter in 1971, our neighborhood association has been known as Vollintine-Evergreen Community Action Association or VECAA. No longer. The name has been changed to Vollintine-Evergreen Community Association or VECA.

Carl Holmes, President of the Vollintine-Evergreen Community Association, presided over the November 16th general membership meeting held at McLean Baptist Church. Despite the rainy weather, the attendance was representative of the large V/E area.

One of the main topics of business for the evening was consideration of By-Laws changes. At the recommendation of the Executive Committee, the general membership of VECA voted unanimously to approve the name change and all other proposed changes in the VECA By-Laws. Every By-Law was changed in some aspect — some minor and some major changes.

The word "Action" was deleted from the name of the organization, because a prior attempt to obtain a postal mailing permit for a tax exempt organization was thwarted by the use of that word in VECA's name. The word was included in VECA's name originally simply because it was a fashionable word in the early '70's. VECA will still be pronounced the same way.

Membership dues were changed from \$2.50 annually per family unit (with a maximum of two votes per family) to \$2.50 annually per person, and anyone at least 18 years of age living within the VECA boundaries may be a voting member.

Traditional boundaries for the VECA area were formalized as Cypress Creek on the north, Springdale-Trezevant on the east, the Interstate 40 highway right-of-way on the south, and Watkins on the west, including both sides on these streets.

A category of membership, known as associate membership, was created for non-residents, who are not entitled to vote or hold office.

The President is now empowered to set the date, time, and place of the annual meeting in January and any regular or special meeting of the membership. A majority of the Executive Committee or at least one-twentieth of the voting membership may call a meeting of the general membership.

Notice requirements of meetings is now spelled out in detail so that all dues-paying members are entitled to at least five days' written notice of any general membership meeting. (Continued on Last Page)

## Charter Amendments

Amendments to the State Charter of VECA will be voted on at the January 15 meeting to confirm the change of name to VECA; to allow the By-Laws to - provide for membership classification; to confirm that the President and Vice President shall be elected by a majority and the other Executive Committee members shall be appointed by the President; to confirm 10% as the quorum for general membership meetings; to prohibit any activity which would jeopardize federal tax exempt status; and to provide for distribution of the Association's assets to a tax exempt organization similar to VECA if and when VECA is dissolved.

## **VOLLINTINE COURTS LAWSUIT**

As most of us living in the VECA area have noticed, the condition of the apartment complex at Watkins and Vollintine is deplorable at best and getting worse as time progresses.

Both the general membership at the regular November meeting and the VECA Executive Committee have voted to file a lawsuit to force local, state, and federal governments to adhere to ordinances, statutes, and regulations currently not being enforced, and to either clean up or tear down this cancerous eyesore which is blighting our area.

VECA resident Attorney Thomas F. Turley has volunteered to lead the legal fight at no charge. The suit will, however, require numerous out-of-pocket costs that the VECA general treasury cannot and should not absorb. Mr. Turley has estimated that Court costs, Court Reporters' deposition fees, photocopying, and other expenses will amount to at least \$1,500.00, and possibly more, depending upon the length and complexity of the litigation.

The name of the Steering Committee was changed to the Executive Committee. The name of the Chairman of VECA was changed to President. The position of Vice President has been created and will be elected by the general membership at the annual January meeting, along with the office of President. The terms of these officers have been limited to one year each and no more than two terms consecutively.

The President, Vice President, Secretary, Treasurer, Editor of the Evergreen News, the Chairman of all standing committees, and anyone else designated by the President compose the Executive Committee, which functions as, and performs the duties of, a Board

of Directors.

Monthly Executive Committee meetings may now be called by any two members of that body if the President fails to do so. Members of the Executive Committee may now send substitutes to attend and vote in their place at such meetings, subject to the approval of the President.

The Treasurer is now required to submit at the annual meeting, a written annual accounting of the Association's income and expenses for the preceding year

## **NEW AD RATES**

Effective with the February/March combined issue of the *News*, there will be an increase in the price for commercial ads. The *News* last increased rates in April of 1976, so this will be only the second rate change in nine years.

The new prices will be \$7 for a small box ad (1 1/8 x 2 3/8 inches) and \$14 for a large box ad (2 3/8 x 2 3/8 inches). The new rates are still a bargain — Center City charges \$10 per column inch (1 x 2 1/2 inches). Rising material and production costs necessitate the new rates to insure regular publication of the News. Although ads for just one month will be accepted, subscriptions of at least three months will be of assistance in budgeting for the News. There is a first-time charge of \$3 for typesetting an ad.

The rate for classified ads (20 words or less) will be only \$1 as this section is looked upon as a neighborhood service. Deadlines for ads will appear monthly in the staff insert of the *News*. All inquiries regarding ads should be directed to Sue Fagan at 272-3776.
