'HE RICHARD BORYS AWARD

Richard Borys moved to the Vollintine-Evergreen community in 1975 and served as president of the Vollintine-Evergreen Community Association and on various committees in the early years of the organization. Despite dying young at the age of 44, Dick's life was an example of public service. Dick came to Memphis as a VISTA volunteer. He helped design and start the Memphis City and Shelby County Pre Trial Release Program. In 1976 he was awarded the outstanding service award from the Memphis and Shelby County Bar Association for his contributions to the Criminal Justice System. At the time of his death Dick was a vice president at the Regional Medical Center ("The Med").

Dick was active with his children in soccer, coaching up to three teams at a time. He was a member St. Therese Little Flower Church, located at the center of the Vollintine-Evergreen community Clearly, Richard Borys served the community in his work, in the neighborhood, at church, and through his children, Claire, Alex and Pete. Dick's wife Julie M. Borys still resides in Vollintine-Evergreen and has herself served as VECA president and active volunteer over the years. She currently is on the VECA CDC Board of Directors.

The Richard S. Borys Award was created to recognize public officials who through their work contribute to the Vollintine-Evergreen community. The awardee need not be a Vollintine-Evergreen resident or a VECA member.

VECA AWARDED EDUCATIONAL GRANT FROM E.P.A

On October 7, 1998 VECA received confirmation from Representative Harold Ford Jr.'s office that VECA has officially been awarded a \$20,000

Educational Grant from the Environmental Protection Agency (EPA) to beautify the Cypress Creek corridor. The grant was written and submitted by Rhodes College intern Emily Passini last spring. Congratulations and thank you Emily!

The grant has three specific purposes: to conduct a neighborhood survey to increase environmental knowledge, to do environmental sample testing of the Cypress Creek floodplain, and to support a committee of neighborhood residents to coordinate the project.

The first meeting of the Cypress Creek Beautification Committee was held on October 20, 1998 to inform committee members of the details of the grant. Residents in attendance at the meeting were recruited to become phone surveyors to conduct the survey during the month of November.

Meetings for this committee have been scheduled at 7pm on the third Tuesday of every month at the VECA office. Future meetings of the Cypress Creek Beautification Committee will focus on identifying goals and tasks for itself to improve the neighborhood usage of Cypress Creek.

STRATEGIC PLAN SUMMARY

The VECA CDC Board recently wrote, rewrote, and finally approved a Strategic Plan that should provide a framework for VECA, VECA CDC, committees, staff, and volunteers as our Vollintine-Evergreen neighborhood continues in the post-NPI era (explained below). Following is an "executive summary" of the Strategic Plan; anyone interested in seeing a copy of the full version may call or stop by the VECA office (1680 Jackson).

Introduction

VECA CDC must make difficult business decisions in order to support neighborhood goals.

• The VECA Connection

Vollintine-Evergreen is a demographically diverse community which has created various organizations that are linked to the Vollintine-Evergreen Community Association (VECA).

VECA received a National Preservation Initiative (NPI) grant of \$975,000 from the Pew Charitable Trusts for work done from 1995 through 1997 The NPI program was immensely successful and it resulted in at least 16 major positive outcomes.

Mission Statement, Goals and Programs

VECA CDC is the business arm of the neighborhood association and it works to improve the overall quality of the neighborhood. VECA CDC administers programs that are comprehensive in nature and address the needs of neighborhood residents.

Specific goals include: 1. increasing home ownership and reducing dilapidated housing; 2. improving conditions of the neighborhood at the block level; 3. improving the neighborhood greenways and other environmental conditions; 4. revitalizing the commercial centers of the neighborhood; 5. preserving neighborhood diversity; 6. increasing the financial stability of VECA and VECA CDC; 7 building an effective organization which uses sound business principles; and 8. collaborating more closely with VECA and the family of VECA organizations.

Board Organization at VECA CDC

VECA CDC Board committees include the Managing, Budget and Finance, Housing, and Commercial Redevelopment Committees.

Board Organization at VECA

VECA Board committees include the Block Clubs, Code Enforcement, Historic, Youth, and Greenways Committees. There will be increased efforts to coordinate the work of the VECA Board and the VECA CDC Board, especially through a process of board training and orientation. The process of evaluating the effectiveness of the two board structure, and assessing where the organization should move, will take place among the three constituencies of the VECA Board, the VECA CDC Board, and staff. Then, the VECA Executive Committee, the VECA CDC Managing Committee, and the Executive Director will meet in a joint session to evaluate the discussions and to make a recommendation.

Staff Organization at VECA CDC and VECA

The organizational chart places staff management directly with the Executive Director. It proposes five additional staff positions: Fiscal Manager, Office Manager, Economic Developer, Volunteer Coordinator, and Neighborhood Preservationist. The authority to hire and fire is explicitly given to the Executive Director. A statement of organizational culture includes neighborliness, initiative and zealousness.

Productivity and Costs

The products of VECA CDC must be of high quality. Cost overruns will be avoided. Neighborhood rehab standards will be adopted. All employees are compensated by grants and thus will not be continued on staff if grant funds are unavailable. There will be increased use of computers and all staff will be computer literate.

Financial Stability

After tackling 44 houses in three years, VECA CDC is slowing the development for the remainder of 1998 in order to handle administrative matters. In addition, specific financial procedures are being put into place which require a balanced budget and a continuous income stream. Development fees will be increased and a new accounting system will be purchased. Financial operations will provide timely information.

Funding

Under the direction of the VECA CDC Board, the Executive Director will develop a funding plan which will provide the organization with a predictable income stream. A

• The Commercial Redevelopment Program

With the completion of the commercial study by E.T.I., the commercial redevelopment program is ready for implementation, and greater involvement by staff, the VECA CDC Board, and other volunteers can begin.

Housing Strategies

Both strategic development and dilapidation will continue to be selection criteria for house purchases. Housing funds have been spent on Watkins Village, Faxon, the Stonewall cluster, and the Brown/Edward cluster. Watkins Village and Faxon were undertaken for strategic development, while Stonewall and Brown/Edward came about because of dilapidation criteria.



Brown/Howell and Maury continue to be strategic development areas. In addition, there will be development of more moderate income housing that meet these two criteria. The housing program will continue to work in a comprehensive fashion and will utilize block clubs, code enforcement and beautification efforts.

Housing Programs

The housing programs are well developed and will continue to be used as funding sources and opportunities to purchase become available. The programs include housing rehabilitation ("rehab"), new housing, the small loan program, land banking, home ownership training, and rental apartments.

Neighborhood Programs

Although not highly funded and thus dependent on volunteers, the neighborhood programs are highly developed and are a priority. The block clubs have a high priority rating for funding and staff activities will be supported. The Youth program has helped develop and run a youth service and leadership "camp" in conjunction with Bridge Builders. The Greenways program has a viable V&E Greenline and a Jackson Avenue beautification effort. The Cypress Creek environmental program has quietly developed with staff and intern efforts and has received an EPA grant to do environmental testing and community outreach.

Implementation

The Executive Director has provided six-month and twelve-month implementation strategies for the components of this plan.

SIX MONTH ACTION PLAN (JULY 1998 - DECEMBER 1998) - PROPOSED GOALS:

VECA and VECA CDC will be working on the Annual Work Plan for activities to be accomplished during the calendar year of 1999. It is imperative to use this planning time to celebrate what we have accomplished, how we were successful and where we could make improvements.

We should carefully look at the quality of what we are doing. In the past much of our effort has been in meeting the numbers or production deadlines to the detriment of such issues as keeping good records, developing policy and procedures for the different programs, and developing a long-term funding strategy. By implementing the needed record-keeping systems, policy and procedures, and long-term funding strategies, we will insure that VECA will be able to continue to be one of the most productive neighborhood organizations in Memphis.

In the short term we need to turn our efforts from high production to where we want to go from here and what is the best way to get there.

For the next few months we need to put our emphasis on finalizing our financial and program records reorganization, developing grant proposals that will improve our cash flow, developing and review the policies and procedures of all programs, and getting staffing and volunteer resources up to the desired and needed levels to meet the level of activity of the various Vollintine-Evergreen community programs.

SIX MONTH ACTION PLAN (JULY 1998 - DECEMBER 1998) PROPOSED OBJECTIVES:

Management:

- 1. Expand and revise the personnel policies and procedures by September.
- 2. Finalize the apartment rental policies and procedures by September.
- 3. Review VECA's insurance coverage and propose changes by September.
- 4. Hire by contract the staff position of Fiscal Manager by September.
- 5. Prepare a balanced budget and submit it to the VECA Board by November.
- 6. Submit new policies and VECA CDC Board nominees to the VECA Board by December.
- 7 Devote one board meeting to making VECA CDC more business-like.
- 8. Expand staffing as funds are available and develop volunteer resources to support VECA programs as funds are available.

Budget and Finance:

- 1. Draw down neighborhood funds held at the Community Foundation by September.
- 2. Obtain signed contracts for the 1997 CHDO proposal and the 1998 FHO (Foundation for Home Ownership) Rehab Small Loan program by September.
- 3. Prepare a short term funding inventory of grant proposals (those already made, those to be made by January, and those to be made after January) by September.
- 4. Prepare a fund raising plan which includes a variety of funding sources by October.

Housing:

- 1. Rehab the vacant apartment at 795 Maury by August and rent it by September.
- 2. Incorporate Brown/Howell residents in the Housing committee by September.
- 3. Purchase Brown/Howell lot for Rhodes College chapter of Habitat of Humanity (in accordance with the VECA CDC commitment) by September.

- 1. Finalize commercial redevelopment work plan by September.
- 2. Develop proposal to the MCDP for the commercial work plan as a new program direction of VECA by October.

TWELVE MONTH ACTION PLAN (JANUARY 1999 DECEMBER 1999):

Management:

1. Devote the February 1999 VECA CDC Board meeting to celebrating 1998 accomplishments and Board development and orientation.

Budget and Finance:

- 1. Prepare proposals to HCD by January 1999.
- 2. Sell four rehabbed houses by May 1999.
- 3. Sell four more rehabbed houses by October 1999.
- 4. Carry out the long range funding plan.
- 5. Prepare a proposal to liquidate the debt and to improve the facilities at the VECA office to solidify it as the center of the Vollintine-Evergreen community.

Housing:

- 1. Prepare a proposal to HCD and other funders for a "model block" project at Brown/Howell by January 1999.
- 2. Start rehab of the 820 Maury apartment building during the summer of 1999.
- 3. Complete the rehab of eight houses by August 1999.
- 4. Start the "model block" project in Brown/Howell during August 1999.
- 5. Complete the FHO Rehab Small Loan program for 12 houses by August 1999.

Commercial Redevelopment:

- Prepare proposals to HCD to support the Commercial Redevelopment program by January 1999.
- 2. Implement funded commercial programs during the summer of 1999.
