

## HISTORIC COMMITTEE

## HOUSING COMMITTEE



The Housing Committee started as the Acquisition and Sales Committee, and was responsible for approving purchase of properties for rehabilitation, reviewing the construction process, and helping to find buyers. The Committee now also reviews new programs and funding sources, recommends CDC Board approval for staff to pursue them, and monitors their implementation. Programs now include a low-interest small loan/grant program for homeowners with limited income, rehabbed housing, some new construction, and the possibility of VECA ownership and management of multiple housing units. Realizable goals are determined by the funding that becomes available.

## **GENERAL VOLUNTEERS**



Being a general volunteer is probably the best position in the whole family of Vollintine-Evergreen organizations. Not only can you choose what you would like to do, you can usually set your own hours. Volunteers are needed at the office to do telephoning as well as help with mailings. ## BROWN/HOWELL REPORT

The Brown/Howell Block Club continues its many activities.

In April, neighborhood residents and members of Springdale Baptist Church pitched in to scrape and paint a home on Springdale that had been cited by Code Enforcement. Materials were donated by MLGW's "Project Max" program and by the Hyde Family Foundation. The transformation is dramatic!

The Block Club won a \$1000 grant from The Memphis Flyer for a "Sweep Around Your Own Front Door" contest, in which gift certificates will be awarded monthly throughout 2000.

Residents are looking forward to repaving of their streets, with a projected date of June 2000. Speed bumps are also being considered, which will be a welcome improvement, since Howell is the main entrance to, and Brown the main exit from, Cypress Junior High School.

Gary was new to Vollintine-Evergreen in 1998, but with his wife Sandy Call, he immediately became a homeowner in the neighborhood, and immersed himself in our work. Gary is known for working hard, running an efficient office, and communicating effectively.

## BUCKMAN LABS HOSTS CONSERVATION AWARD RECEPTION

On May 10, Buckman Labs hosted a reception during which about twenty-five Vollintine-Evergreen residents met several Buckman Labs employees for refreshments, orientation, and an extensive tour of Buckman's offices and plant at McLean and Chelsea.

The excuse for the get-together was VECA's selection for the Tennessee Conservation League's 1999 Conservation Organization of the Year award, for work on the V&E Greenline, Cypress Creek, and Jackson Avenue Beautification. Buckman nominated VECA for the award, and was itself nominated for the Industrial Conservationist award. Buckman's Richard Lutey coordinated the reception and greeted everybody to it.

Mike Kirby, a longtime Vollintine-Evergreen resident, V&E Greenline activist, and Rhodes College faculty member, spoke of the trip that he, Jan Kirby, and Richard Lutey made on April 14 to Paris Landing State Park to accept the conservation award. Besides the value of the conservation work itself, people from all over Tennessee praised the unusual and fruitful collaboration of a neighborhood association (VECA), an industry (Buckman), and an institution of higher education (Rhodes College). Mike also noted that the Tennessee Conservation League has always been concerned with urban sprawl and its impact on our remaining wild areas; by making our Vollintine-Evergreen neighborhood and other parts of "old" Memphis more attractive places in which to live and work, we are doing our part to combat urban sprawl.

Buckman Labs employs over 1000 people worldwide, including over 500 at its world headquarters here, just north of our Vollintine-Evergreen neighborhood.

## ENVIRONMENTAL EDUCATION AND CYPRESS CREEK

It's summer! And since this means that school is out, you might be wondering — what could we possibly be doing concerning environmental education? The answer — we are doing quite a bit. A major part of the Cypress Creek project (part of the United Way proposal) involves educating area youth about environmental problems. Two new interns, Kirsten Williams and Tim Moreland, have begun developing a plan approaching environmental education with some local youth this summer. We are also planning on extending environmental education to some of the local schools this fall, in order to help prepare the next generation of neighborhood environmental leaders.

The first question raised in developing an approach to environmental education using Cypress Creek is very basic: What is environmental education? There is, of course, the simple answer — education about the environment — but that isn't much help, for it is so broad that almost anything could be considered environmental education. Instead, we would like to think that environmental education means giving students an understanding and respect for the systems that are part of our environment, as well as a genuine understanding of how humans can affect the planet for good or for ill.

Such an understanding comes hard to most people without a concrete, true example which has relevance in their own lives. Cypress Creek is the epitome of such an example. In looking at the pollution of the creek, we can see very clearly how human activity can harm the process of nature. The floodplain and creek bed are filled with all kinds of wildlife and plants, yet it is not yet a place of which the neighborhood can be particularly proud. The trash and dumping that have gone on both in our area and upstream disturb and make hazardous what could potentially be a beautiful, useful area.

Yet Cypress Creek is not just an example of the problems people can cause, but also of how people can come together to try and solve these problems. During a May meeting with other local neighborhood organizations, it was decided that Cypress Creek is a community problem whose solution we will all have to work on, both collectively and individually. In doing this, we hope to reclaim and undo the harm that has been done.

We hope that in educating the youth about the problems of, and possible solutions for, the Cypress Creek area, they will come to better understand how environmental issues affect them and ways in which we can all help, such as participation in cleanups, proper use of storm drains, proper recycling or disposal of wastes such as used motor oil, proper use of chemicals such as pesticides and herbicides, and active participation in the decisions which are made about the creek.

#### WATCH OUT!

Be aware of who is on your telephone when you answer it, and pay special attention if the caller is asking you for money. Most of these calls are in the evening. In the Vollintine-Evergreen area, many people are being asked for money for emergencies, often medical ("my daughter needs dialysis") or automotive ("I just need a little gas"). Some criminals are smart enough to only ask for small amounts of money, such as \$20. Never give them cash, even if they claim to be a neighbor or a distant family member. And if you have doubts about a call related to a charity or a business, don't commit to anything but instead ask for written details by mail, and then contact the local Better Business Bureau at 759-1300.

## JOIN THE "STREET LIGHT" PATROL"



Consider this: The employees of MLGW's Outdoor Lighting department are responsible for maintaining more than 100,000 street lights and leased outdoor lights across Shelby County. They complete an average of 3,500 maintenance calls each month, but they need your help.

You can be a part of MLGW's "Street Light Patrol" by reporting street lights that burn throughout the day, lights which continually cycle on and off, or lights that aren't burning at all.

To report a street light problem, note the street light number stamped on the metal plate attached to the pole (the street address is the next best thing), and call MLGW's Outdoor Lighting department at 320-1497 anytime. If no one answers, leave a message on the recorder and they will respond to your request as soon as possible, usually within 24 hours.
