#### TO TREE OR NOT TO TREE

"Summer Storm 2003" was particularly devastating to our Vollintine-Evergreen neighborhood. Homes were damaged to varying degrees, families were without power for days, and many are still working to recover from the damage wrought by the storm. In addition to the damage to personal property, our neighborhhod lost numerous large established trees that were such an integral part of the langscape of our neighborhood.

On Saturday, November 8, VECA will help host "To Tree or Not to Tree" at 2597 Avery
Avenue (at Hollywood), in the Board of Education Auditorium. The free program will run from
9:00 a.m. to noon and will include nursery companies, arborists, and other tree experts. Topics include:

- why should I plant a tree?
- · should I plant a large or small tree?
- how do I successfully plant a tree?
- how can I save a damaged tree?

Plans are being made now to obtain many large trees, for planting in the Jackson Avenue median, on the V&E Greenline, and in yards of many Vollintine-Evergreen residents who are interested.


The VECA Board appoints the CDC Board. Those terms are for two years. So the CDC Board will have some members continuing, but there will also be vacancies.

#### THE MARGARET DICHTEL AWARD

Margaret Dichtel was one of the founding members of VECA and its first president. She strongly believed that neighbors working in a community organization could accomplish together what they as individuals or government could not. Her faith in the value of neighboring and the importance of grassroots community action remains the VECA philosophy.

The Margaret Dichtel Award is presented annually to a Vollintine-Evergreen resident and VECA member who embodies the principles of neighboring and community action. There is no specific length of membership required and the awardee need not be an officer. The awardee will be an individual who strengthens relationships between community members, tackles problems that threaten the integrity of the community, makes the neighborhood a better place to live, improves VECA's image city-wide, and demonstrates a commitment to the neighborhood and the concept of a neighborhood.

Each nomination must be by a current duespaying member of VECA and should consist of a letter stating the candidate's contributions and achievements. Send nominations by December 31 to the Nominating Committee, care of the VECA office.

#### THE RICHARD BORYS AWARD

Richard Borys moved to the Vollintine-Evergreen community in 1975 and served on various committees in the early years of the organization. Despite dying young at the age of 44, Dick's life was an example of public service. Dick came to Memphis as a VISTA volunteer. He helped design and start the Memphis City and Shelby County Pre Trial Release Program. In 1976 he was awarded the outstanding service award from the Memphis and Shelby County Bar Association for his contributions to the Criminal Justice System. At the time of his death Dick was a vice president at the Regional Medical Center ("The Med").

Dick was active with his children in soccer, coaching up to three teams at a time. He was a member St. Therese Little Flower Church, located at the center of the Vollintine-Evergreen community. Clearly, Richard Borys served the community in his work, in the neighborhood, at church, and through his children, Claire, Alex and Pete. Dick's wife Julie M. Borys still resides in Vollintine-Evergreen and has served as VECA president, on the VECA CDC Board of Directors, and as active volunteer over the years.

The Richard S. Borys Award was created to recognize public officials who through their work contribute to the Vollintine-Evergreen community. The awardee need not be a Vollintine-Evergreen resident or a VECA member.

Each nomination must be by a current dues-paying member of VECA and should consist of a letter stating the candidate's contributions and achievements. Send nominations by December 31 to the Nominating Committee, care of the VECA office.

#### THE MARTHA HEINEMANN AWARD

Martha Heinemann grew up in Hot Springs, Arkansas, graduated from Southwestern at Memphis (now Rhodes College) in biology, and earned her Masters degree from University of Arkansas in biochemistry. She was a research chemist at the University of Tennessee and the Veterans Administration hospital. Besides her volunteer work with VECA, Martha was associated with Rhodes Alumni, Memphis Symphony Orchestra, Brooks Museum, and the Tennessee Ornithological Society.

The Heinemann Award honors a Board member who has rendered exceptional service to either the VECA Board or the VECA CDC Board. The Nominating Committee will select one winner from either Board.

If not I will help serve as your voice to insure that every effort is made to determine the scope of the problem and that effective remedial activities are undertaken.

I want to help each of you feel good about what is being done to protect you and your family's well-being and your property. ## CYPRESS CREEK SOIL STUDY PROGRESSES

When we first started meeting with members of the VECA community a year ago, we made a commitment. Velsicol will gather the information needed to determine if there are potential health effects from soil contamination in and around Cypress Creek, share it with you and help you understand what it means.

Between late April and early July, Velsicol collected 124 soil samples and the United States Environmental Protection Agency collected another 38 from nearly half of the properties in what is called Sub Area III, which runs from Jackson Avenue to Evergreen Street.

Based on the information collected, the Tennessee Department of Environment and Conservation and Velsicol's consultants concluded that there are no imminent or acute health risks associated with contamination. That's great news, but the process needs to continue. Now we need to look closely at some of the properties where there is an elevated level of contamination and determine if there are risks due to chronic or long-term exposure.

If you gave permission and your property was sampled, you will receive a summary of the results, including a description of what the data means, in mid to late November. If samples from your property show elevated levels of contamination, additional sampling will be done at adjacent properties that were not sampled, and more samples may be collected from your

property.

Typically, once the additional information is gathered, we would expect to conduct a human health risk evaluation for long-term exposure. Part of that evaluation is identifying potential alternatives for fixing problems that may exist. In the meantime, the Memphis and Shelby County Health Department have announced their commitment to conducting a study to evaluate cancer rates in the Cypress Creek area. The Health Department epidemiologist will meet with representatives from the VECA community as soon as possible to explain the study design, what the results may reveal, and to obtain input from community members. This is another good step in helping area residents answer the question of whether the health of the Cypress Creek residents is significantly different than residents in other areas.

#### ALEX'S CELEBRATES 50TH ANNIVERSARY

Alex's Tavern, tucked away in a small strip of stores on Jackson near Watkins, has a rare event to observe in November, It's something no other tavern in Memphis can match. Alex's is the oldest fami-



ly owned tavern in Memphis and a month long celebration is planned to mark the occasion.

The tradition, started by the late Alex Kasaftes and his wife, Eugenia, is now carried by their son, Rocky Kasaftes who said the concept taught to him by his parents has remained the same "treat the customer right, and they'll come back." Rocky has managed the pub since 1978 and is a familiar face in the Vollintine-Evergreen neighborhood.

"To many, a tavern is a really a neighborhood 'club'," said Kasaftes. "It's a place where people can meet friends in their spare time, have something to eat and a beer or two, without spending a lot of money. "We just try to give the customers what they want," said Kasaftes, He said he always remembers what his father told him about his formula for success "It's not how many customers come, it's how many come back." Alex also told his son the importance of keeping the menu simple, but consistent.

A large, framed picture of Alex Kasaftes still hangs over one of two CD-jukeboxes, which constantly play a combination of hits and have also become one of the tavern's primary attractions. Rocky said he has always been a fan of "oldie" music and the customers frequently compliment him on the unique collection. The tavern has been honored several times by the Memphis Flyer with its' "Best Jukebox Award" and a Memphis radio station's listeners gave the "Best Hamburger" Award to "Alex's".

Since Alex's Tavern is near Rhodes College, UT-Memphis, and Southern College of Optometry, hundreds of "class parties" have come and gone and many alumni have returned, even after graduation, to hold reunion parties. Alex's also sets aside at least one night a year when some of the current college students can bring their parents by.

Sports fans are also a major part of "Alex's" clientele (the bar was being called a "sports bar" long before that term was common), and a huge, big-screen television was the first in town. Since then, several more have been added. The satellite dish at Alex's - also one of the first in Memphis - offers frequent sporting events that can't be seen on network TV or cable.

Alex's has played host to a long list of well-known names such as actress Stella Stevens, actors John Schneider and David Keith, baseball's Tim McCarver, and musicians Don Henley, Joe Walsh, Belinda Carlisle, Greg Allman, and Billy Gibbons of "ZZ Top". The popular band "Chicago" has stopped in the bar two times after appearances in Memphis.

Kasaftes said, "We've made a lot of friends in the Vollintine-Evergreen area over the last 50 years, but we're always happy to meet our new neighbors. We would like to invite all the new residents to the area, as well as the older ones, to stop in anytime for a cold beer and a great burger."

#### PROPERTY INSURANCE ADVICE

based on September 20's presentation to VECA by Richard Coletta, C.I.C.

In case of property damage such as that experienced by many Vollintine-Evergreen residents in the July 22 windstorm:

- immediately do what is reasonable and prudent to prevent further damage and injuries, but do not do more than necessary until you have the permission of your property insurance company
- contact your property insurance company as soon as possible
- keep detailed written records of all calls to or from your insurance company and anyone you contact about repair work
- · photograph or videotape all damage
- keep a detailed written list of all damage
- · keep damaged items if possible
- · keep receipts and a detailed written list for all repair work
- be careful when hiring people to do repair work; disasters often bring higher prices as well as unqualified or even dishonest contractors
- · use common sense

In preparation for potential disasters:

- make sure that your house number is clearly visible from the street
- photograph or videotape your important personal property and your house
- keep a current list of important personal property, with full description, serial number, date purchased, and price
- give a current copy of your personal property list to your property insurance company or agent
- store offsite (perhaps at work) a current copy of your personal property list in case your home is severely damaged

During both normal times and times of disaster, make sure that contractors you hire are licensed, bonded, and insured. Ask to see a current license in the appropriate field (roofing, carpentry, etc.). Also ask to see a current certificate of insurance showing adequate general liability and workers compensation coverage. Check with the Better Business Bureau (901-759-1300). Get a detailed signed contract before work begins.

Finally, questions frequently arise regarding our beautiful large trees. If a tree growing on one property (Smith's) falls on another property (Jones's), normally it is up to Jones to remove the tree and repair the damage. Insurance will normally only cover removal of the portion of the tree that caused the damage or threatens to cause further damage. (In this situation, "damage" applies to house, garage, storage building, vehicle, etc.; it does not apply to simple cleanup or tree removal.) However, before Smith's tree falls, if Jones has good reason to feel that Smith's tree threatens Jones's property, Jones can send Smith a letter by certified mail expressing his concern in writing. This may shift some of the burden to Smith if and when there is a problem with the tree in the future.




#### OCTOBER-2156 VOLLINTINE

#### TREE ADVICE

based on September 20's presentation to VECA by Mark Follis, Ph.D.

The July 22 storm has made tree replanting this fall critical if Memphis is to restore the hardwood canopy for which the city is rightfully famous. Although trees can be successfully planted and transplanted in all seasons, planting after mid-October has distinct advantages. First, fall plantings are less subject to moisture stress because of the lower temperatures and leafdrop. They also have more time to overcome transplant shock and establish viable root systems before the heat of the following summer.

Proper species selection is equally important for long-term viability. Excellent choices for this region are the willow (often incorrectly referred to as a pin oak), northern red oak, and white oak. Avoid the true pin oak at all costs — it has too many serious disease problems. The tulip poplar (Tennessee's state tree) is a beautiful fast-grower but the trunk must be kept distant from sprinkler heads and free of mulch. Two grossly underplanted native trees with stunning fall coloration are the Swamp Chestnut Oak and the Black Gum. Be sure to consider tree size at maturity and avoid planting larger trees in small lots and under utility lines. As for existing trees, look for discolored, undersized or prematurely falling leaves which may indicate problems. Other important problem symptoms include mushrooms or other fungal growths anywhere on a tree, termite tubes, and "sawdust" which may indicate destructive insect activity. Call a certified arborist if you have questions.
