# VOLLINTINE-EVERGREEN 2006 HOME TOUR AND SPRING FESTIVAL - APRIL30

The Vollintine-Evergreen National Historic District will showcase seven of its historic residences and a distinctive church during the neighborhood's home tour and spring festival on Sunday, April 30th. Although this year's tour is highlighting the way that the neighborhood's homes, which suffered extensive damage during Hurricane Elvis, the 2003 straight line wind storm, have re-emerged in new and exciting ways, this entire midtown neighborhood is in the middle of a rebirth.

A neighborhood committee has spearheaded the planning of new trees to replace those damaged in the straight line winds; new homes are being built by the neighborhood's Community Development Corporation and by local builders; existing houses are being reno-

vated and expanded; the old railroad bed has been made into the V&E Greenline, a neighborhood-owned walking trail and gardening space; and home values are rising. New residents are moving in alongside those who have lived here for decades. The owners of the homes on the tour represent this mixture. Several families are relatively new to the neighborhood, moving in from other historic Memphis neighborhoods and from New York. One family moved into their home from next door. One family went to their first neighborhood meeting the night they moved into their home, 35 years ago.

"Why is our neighborhood experiencing this rebirth? It is because we share a commitment to community that is reflected in our daily lifestyles," said Lisan Parker, a member of VECA's Historic Committee. To celebrate this renewal, Vollintine-Evergreen will host its Home Tour and Spring Festival on Sunday, April 30th.

The tour will feature:

- 2056 Hallwood a 1930 Tudor architectural jewel with a fabulous new kitchen
- 1949 Jackson a 1927 Tudor cottage that presents an interesting combination of practical and decorative
- 934 North McLean a Tudor cottage with many faces, with themes of African and Asian heritage and family
- 1946 Mignon a 1924 Craftsman bungalow incorporating the best of the past and present
- 1999 Mignon a 1941 classic Colonial built using a Better Homes and Gardens Home Plan
- 773 University a 2004 Tudor that was the winner of last year's best new residential structure constructed in a Memphis Historic District
- 867 Hawthorne a 1927 Tudor cottage that reveres the past
- 815 North McLean a 1932 Colonial church that lost its sanctuary but renewed its commitment to the community

The Home Tour will take place from 12:30 p.m. to 5:30 p.m. on Sunday, April 30th. Tickets are \$10. Visitors can purchase tickets at McLean Baptist Church, 815 North McLean at Jackson, and then catch free trolley rides to each home on the tour. The Spring Festival, also at the church, will feature face painting, games, a petting zoo and pony rides.

### **RESIDENT ART SHOW BENEFITS VECA CDC**

Vollintine-Evergreen resident Dottie Sachritz and fellow artist Liz Bass will have an art exhibition at Gallery 32 from March 16th through April 23rd. The gallery is located at 1918 Exeter Road, Suite 1, in Germantown, across from the library.

Please note that 25% of gallery profits will be donated to VECA CDC and to the Hernando-Desoto Chapter of Habitat for Humanity. Here is your opportunity to buy some great art as well as to support great programs.

### **VECA CDC AND YOUTHBUILD**

VECA CDC recently joined forces with a federally-funded program called YouthBuild that results in quality affordable housing while training young people in basic construction trades and helping them attain their high school general education diploma (GED).

The first YouthBuild house in the Vollintine-Evergreen neighborhood is being constructed at 1902 Vollintine Avenue. It will have three bedrooms, two full bathrooms, and all the modern amenities, yet its design and all-brick exterior will fit our historic neighborhood.

Under this particular YouthBuild grant, most of the general labor is being provided by Shelby County prison inmates. These young people are minimal security nonviolent offenders, have been carefully screened, will be transported to and from the building site and continually overseen by Corrections officials, and will be supervised and taught by skilled union carpenters. YouthBuild has built hundreds of houses in Memphis, and there has never been an incident involving a worker. Because of the combination of labor supplied by the YouthBuild grant as well as funding supplied by the City of Memphis, VECA CDC will be able to sell this new house at a below-market price to a qualified buyer.

Obviously this collaboration involves many partners. Besides Shelby County Housing Shelby County Corrections, and the Tennessee Carpenters Local Union #345, we are grateful to Rhodes College for greatly simplifying our logistics by allowing our enclosed trailers containing valuable construction equipment to be parked on campus each night.




### **NEIGHBORS FOR TREES**

# BE PREPARED FOR DISASTER: BECOME A COMMUNITY RESPONSE TEAM MEMBER

If there were a significant earthquake today would you be prepared to manage light search and rescue for your family and your neighbors? Do you have all the supplies you need for your family and pets? Do you know how to prepare for emergencies in the aftermath of a quake? The Emergency Management Agency of Memphis and Shelby County have a wonderful free program that will help you plan to save your life.

The Community Emergency Response Team (CERT) program educates people about disaster preparedness for hazards that may impact their area and trains them in basic disaster response skills, such as fire safety, light search and rescue, team organization, and disaster medical operations. CERT members can assist others in their neighborhood or workplace following an event when professional responders are not immediately available to help.

#### **VELSICOL BEGINS CLEANUP PROCESS:** Soil is removed and replaced at three properties along Cypress Creek

Velsicol reached an important milestone this past fall when we began the cleanup process at properties along Cypress Creek identified by the Tennessee Department of the Environment (TDEC) as having dieldrin levels requiring soil removal. We have finished removing contaminated soils from the first three of these properties (two properties on Edward Avenue and one on Vollintine Cove), and are looking forward to finishing the process on the remaining nine properties as soon as possible. The only obstacle that remains is securing permission from the property owners to begin the cleanup process.

A lot has been accomplished in the past three and a half years. More than 120 properties were tested under the watchful eye of TDEC and the U.S. Environmental Protection Agency (EPA). Outside experts developed information on clean-up goals that is being reviewed at TDEC and EPA and that will be used to establish the remedial action level for residential lands along Cypress Creek. Additionally, the Memphis and Shelby County Public Health Departments completed a health study to address the community's concerns about whether there were elevated levels of cancer along Cypress Creek. These results were shared with the community in April 2005.

While none of this came easily or went as quickly as any of us would have liked, it was a good, thorough scientific process that is directly leading to action - the clean up of properties that have elevated levels of contamination in the soil. Velsicol remains committed to finishing this important project. For those of you who did not see the soil removal process in action, let me explain how it works.

One of our objectives is to minimize the disruption to proper-

ty owners and their neighbors. Our project manager, Gary Hermann, meets with property owners to explain the process and set dates for soil removal, taking into account family schedules. While soil is being removed, workers monitor the air quality. Trucks hauling away contaminated soil are covered with tarps and are thoroughly cleaned before leaving the property. Contaminated soil is taken to a secure consolidation area on Velsicol's plant site on Warford Avenue. Next, clean soil is brought in and put into place and new sod is installed.

Our ultimate goal is to leave a property looking as good as or better than before soil removal, and to make sure yards are restored to the property owner's satisfaction. That includes replanting or replacing landscaping features like trees and shrubs, and structures like sheds and fences, which may have to be taken out for soil removal to take place.

Although our number one priority in the coming months is to complete the soil removal process at the remaining nine properties as well as at any others that may be identified, we want to continue working with leadership organizations such as VECA on how we can all work together on issues of community development. Velsicol shares your vision of a vibrant, attractive community, and wants to help ensure that this is the kind of future we can enjoy together.
