Our community partners, Schnucks' grocery store has collaborated with VECA on a fundraiser.



### New VECA Restaurants by Meredith Cavin

The Rhodes students working at the VECA Welcome Center did a bit of taste testing—see photo to the right. We explored three new restaurants in or near the neighborhood so we can pass on our recommendations! The restaurants are Chicago'z Fast Foods, Lucky Star Chinese Restaurant, and Gereny East African & Mediterranean Restaurant.

Chicago'z is located at 1076 North Watkins Street and specializes in guick indulgent foods. We tried popcorn shrimp, fries and a pizza puff. The shrimp and fries were fried just right. The pizza puff was like a rectangle-shaped piece of pizza folded in on itself, perfect for when you're on the go. We recommend this restaurant for quick meals, snacks, and fried treats.

Lucky Star Chinese Restaurant is at 1420 Jackson Avenue. It has a vast selection of Chinese food. We tried their Lo Mein and beef with broccoli. Both tasted delicious and very fresh. The vegetables are cooked just right and have a crisp crunch that can be hard to find elsewhere.

Rhodes Professor and VECA leader Mike Kirby found his favorite, the Lo Mein, and noted, "The noodles are great." If you're looking for a great lunch special, come by between 11-4 p.m. when you can get any of sixteen different lunches for \$4.69.

Gereny East African & Mediterranean is located at 2356 Jackson Avenue. It's a very unique restaurant and definitely one to try. Upon entering the restaurant, we were immersed in the rich smell of meat and spices.

We ordered Mediterranean Shish Kebabs with steak, lamb, and chicken. The meat was marinated, then grilled and was served on a bed of rice. Rhodes student Lacy Ward, a Texan who loves spicy food, tried the Shish Kebabs and endorsed them strongly, exclaiming, "Order that!" Of the lamb in particular, she said, "It's got a big kick in it. It was so spicy!"

Co-worker Bert Geer agreed, "The lamb was adeptly spiced." The rice on which the meats are served is also unexpectedly complex. It is sweet and seems cinnamon-flavored. Most of the plates here cost about \$10. Remember that they include a lot of food! This is a great restaurant for families to try.

Each of these restaurants has unique flavors, and we recommend you stop by and support your local VECA businesses! 

## Eagle Scout Project by Meredith Cavin

Each young man who pursues the honor of becoming an Eagle Scout must design and implement a project. Jordan Bruce, a high school senior at Saint Benedict, decided to help VECA with his project. His family friend knew VECA board member Marci Hendrix and Jordan learned of a drainage issue at the corner of University and Jackson on the V&E Greenline. The popular intersection had been flooding because of a clogged culvert to carry rainwater away. The culvert had two openings, one of which was clogged with dirt. The other was so filled that it seemed to have disappeared into the earth.

Jordan put together a team to help fix the drainage issue. They began with fundraisers to pay for the materials. Then they cleaned the visible opening of the culvert and put rocks at the mouth of it to catch debris that would have previously clogged the culvert. The group also put a small wooden fence around the ditch and painted it to match the Greenline signs in the area.

The VECA community appreciates all of the effort put forth by Jordan, his troupe of fifteen Eagle Scouts, Jordan's family members, and members from his church. They remind us that, by taking the initiative to fix even one small thing, we are helping our community. See picture on page 6.

## **Vollintine Strip West**

Several VECA board members met with the owner of the strip commercial property at 1570 Vollintine—see the picture below.

This strip is has two separate owners and Jerry Couloubaritis (picture below and to the right) is a co-owner for the section that extends from the bay with the Mid-South Realty banner to the corner of Maury.

Jerry Couloubaritis showed the board members two very large vacant bays—in the past they had housed a total of four stores. Previous tenants were a cleaners, a tattoo parlor, a beauty shop, and a convenience store.

Possible new uses could include a restaurant, a tax preparer, used furniture, cell phones, computer repair, after school tutoring, and may other options that would serve the neighborhood. The limited vehicle traffic on Vollintine Street means that the users would primarily serve the surrounding area.

However, this would be great space for an office that does mail order or does not necessarily provide services. The owner is willing to use an in-kind work by renters as a way of making the rent affordable.

Eddie Harper is a personable business owner of the barber shop at the corner of Maury and Vollintine and he has a thriving business.

VECA discussed concerns which included the condition of the front parking lot and lighting, which the owner agreed to address. VECA also expressed concern about the vagrants at the site and Jerry Couloubaritis said he will give the police permission to remove vagrants from his property.

VECA was very pleased to meet with Jerry Couloubaritis and he was cooperative and upbeat. VECA is considering several other projects with him, including a clean up, paint up effort. The VECA historic committee is look at the site for façade improvements.

VECA plans on continuing to work with the strip commercial areas in the neighborhood with the initial focus on the Vollintine Strip. Next, VECA will examine the collection of businesses at Jackson Ave and Evergreen St, with a focus on the former BP station.




## **Trinity Music Conservatory**

## New Grocery in the Vollintine Strip East by Meredith Cavin

O'Keila and Rashad Alasadi are the new owners of the North Memphis Grocery in the Vollintine-Avalon Strip at 1590 Vollintine Ave.

The couple moved to Memphis from Chicago seven years ago, and they have been in the VECA neighborhood for the past three. They began working at the North Memphis Grocery on May 13, 2009.

They say they do the job to make a living and because they want to help people. The store provides necessities to the community, including all kinds of groceries, seasonings, baking goods, toiletries, and supplies for everyday life. In the mornings they sell coffee and breakfast, which O'Keila, a self-described "people person" says lifts her customers' spirits.

While the store has opportunities for positive community interactions, managing the store is also very challenging. O'Kelia and Rashad were able to buy the store when the previous owners left the neighborhood.

The couple laments that there are "issues" at the corner, including lots of loitering and littering. Many people dump unwanted items steps away from the dumpster which the store has to pay to have emptied.

At times, O'Kelia admits she feels intimidated, like when people try to get stuff for free from the store. As the store represents her livelihood, she must protect both herself and also her business.

She and Rashad are doing a lot to protect and improve the business. Since the change in management in May, O'Keila and Rashad have had a mural painted on the side of their business.

They are thinking of putting up signs discouraging loitering or trash-dumping, and like many other business owners on the Vollintine Strip, they would like to see more lights in the area for increased safety.

Overall, O'Keila notes that it can feel like everyone is on his or her own, and this competitive attitude can override compassion. She would like to see more positivity and unity. She thinks the area needs something to bring everybody together, something positive in all aspects.

O'Keila and Rashad are very kind, dedicated people, so if you would like to share ideas about neighborhood improvement with them, let them know on your next trip to North Memphis Grocery. Also, be sure to say congratulations! The couple is officially tying the knot this winter.

The owners said they also run two other markets, one in North Memphis near Chelsea and one in Orange Mound.





## Lick Creek Meeting Minutes Trevor Wylie

The VECA Lick Creek Committee recently met to discuss possible solutions to the flooding affecting VECA during times of heavy rain. Areas from near McLean Blvd to near Watkins Street overflow their banks. In addition, residents with basements experience problems with the sanitary sewer at these times.

VECA residents affected by the flooding are working on a grant proposal which will help them organize efforts with the City of Memphis to address the problem.

VECA has started surveying residents living along the creek and will continue doing this for the next several months.

The committee thought that there were a number of actions that could be taken by the City: creating retentions ponds to hold water during flooding, creating baffles to slow the flow entering the VECA area and thus preventing some flooding, building retention walls, clearing brush from the walls of the creek, hiring a firm to design retaining lines, or using new slopes to help retain the storm water.

The committee also thought there were some regulatory actions that could be taken by the City, including requiring new development to store rainwater on premises and requiring that parking lots be permeable so that water can enter the ground rather than running off into Lick Creek.

The committee needs more residents to work on this issue who live adjacent to Lick Creek. Call the VECA Welcome Center for more information at 276-1782. The program chair is Mary Wilder; Brian Floyd conducted the meeting of residents.

The City of Memphis Division of Engineering is working with VECA and other Midtown neighborhoods to address these issue. An exciting development is that the City is considering hiring a consulting firm to conduct meetings with Midtown neighborhoods and to provide the City with information on the recommendations from those meetings.

A special thanks is due to City Council Member Jim Strickland for his interest in the issue.
